



7/13/2026 BNTGMC has been awarded a \$3,500 grant from the Bucks County Conservation District (BCCD) for the project:

Measuring and Monitoring Pathways Connecting Surface and Groundwater Quality. The total cost of the project is \$10,000 as Bridgeton, Nockamixon and Tinicum Townships each contributed \$500 and Eco-Bucks contributed \$5,000 matching funds. The project involves water quality testing and groundwater level measurement with remote data telemetry. The objective is to document the influence of the Delaware River on wells situated in the alluvial aquifer adjacent to the River.

2/23/2026

From 1/16 to 2/21 flow data (cubic feet per second) on the Tohickon Creek at Pipersville was unavailable because of ice. Including flow in the local water watch report and watershed budget analysis can now be resumed.

2/22/2026 Penn State released results of their 2025 Private Water Supply Education and Water Testing program. Over 200 private wells, springs, and cisterns were tested in the 2025 program year as part of educational webinars and workshops, helping private water supply owners identify and solve health-related drinking water problems.
